AGREEMENT (Please read carefully before signing)

- ▶ I, the undersigned, acting individually or as the representative of a non-profit organization, hereby agree to serve as a Radio Producer with Gateway Collaborative Media and its broadcast service, GCM Radio 107.1FM (hereinafter referred to as "Gateway Collaborative Radio" or "GCM Radio 107.1FM"). As a Radio Producer, I agree to indemnify and hold harmless Gateway Collaborative Media, GCM Radio 107.1FM, its management, staff, volunteers, and affiliates from any claims arising from programming produced or broadcast by me, including but not limited to FCC violations, libel, slander, invasion of privacy, noncompliance with laws or regulations, licensing fees, unauthorized use of copyrighted material, and any associated legal fees or costs.
- ▶ I agree to comply with all Gateway Collaborative Media and GCM Radio 107.1FM Operating Rules and Procedures, as they may be amended from time to time. I understand that this includes all policies, procedures, and operational guidelines related to any facilities, equipment, or resources I am authorized to use under this agreement.
- ▶ I understand that GCM Radio 107.1FM operates as a Non-Commercial Educational radio station. I agree not to produce, distribute, or broadcast programming intended to generate revenue for any party, nor programming whose primary purpose is commercial promotion, trade, or commerce.
- ▶ I acknowledge that I have completed the Program Proposal process and understand that the Programming Committee reserves the right to review my program at any time and determine whether it will continue to air on GCM Radio 107.1FM.
- ▶ I understand that serving as a Radio Producer for Gateway Collaborative Media and GCM Radio 107.1FM requires current and relevant training in radio operations, station procedures, and applicable FCC policies. I further understand that this agreement is contingent upon maintaining training requirements as determined by Gateway Collaborative Media Management.
- ▶ I grant Gateway Collaborative Media and GCM Radio 107.1FM permission to rebroadcast, redistribute, archive, stream, or otherwise use, in whole or in part, any programming produced using Gateway Collaborative Media facilities and resources under this agreement.
- ▶ I accept full responsibility for any damage to, loss of, or misuse of Gateway Collaborative Media property, equipment, or access devices resulting from negligent or unauthorized use. I agree to reimburse Gateway Collaborative Media for repair or replacement costs and understand that improper use of facilities or equipment may result in suspension or loss of future access privileges.
- ▶ I understand that GCM Radio 107.1FM is under no obligation to air programming produced outside of its broadcast area or outside established station procedures. Any such programming may be scheduled at the discretion of Gateway Collaborative Media in accordance with station scheduling priorities and operating policies.
- ▶ I understand that activities or uses not specifically covered by this agreement, including duplication, syndication, streaming, podcast distribution, or other non-broadcast distribution of programming, may require separate written agreements at the discretion of Gateway Collaborative Media Management.
- ▶ I understand and acknowledge that only members who are at least 18 years of age may serve as a Radio Program Producer for Gateway Collaborative Media and GCM Radio 107.1FM.
- ▶ I understand new content is to be delivered (either in person or digitally) no less than 24 hours prior to air date. If airing on the weekends, content will be submitted no later than 5PM on the Thursday prior to airdate.
